Section II - Summary of Major Activities during Reporting Period

- 1. Sports Core Pool full drain and clean of the pool and resealing of the deck rubber rock.
- 2. Sports Core Pool Clear Comfort, disinfection system, researched and installed on a rental basis to see if it meets our needs adequately. We will be comparing the monthly testing from Health Dept over last year to see the impact on the water. (Smell not as strong, used less chlorine will be interesting if using less chlorine. Check on how much have to fill the chlorine tank. Monthly reports and can compare last months versus this year months. If we chose to purchase drop from \$20,000 to \$10,000 review. Bd approved dehumidifier to be replaced around Thanksgiving. Right now water cooler from nights and air. One of water heaters being replaced.)

Clear Comfort - presently water quality is very good. Rental of the unit is \$5,000 year with the cartridges...\$5,000 will not be put towards purchase. Purchase price: \$20,000. Still use chlorine but looking for it to make air quality better.

3. Sports Core Pool - Heating Unit and Dehumidifier were replaced.

- 4. All pools were covered and secured for the winter season.
- 5. Classes are at their maximum capacity.
- 6. Successful completion of the 4th grade and Home

Schooled Swim Programs.
