### By-Laws & Resolutions Advisory Committee June 7, 2019

Present: Jim Trummel, Audrey Wahl and Bob Hillegass were in attendance. Having a quorum, chair Jim Trummel called the meeting to order at 12:10 PM.

The agenda for the meeting was unanimously approved.

The minutes of the May 3, 2019 meeting were unanimously approved.

**PUBLIC COMMENTS:** None.

#### **UNFINISHED BUSINESS: Update of Resolution Status.**

F-03 Financial Reserve Accounts and F-04 Delinquent Assessments: The amendments to these two resolutions were approved on second reading at the June 1, 2019 Board meeting. It was noted that the provision in F-03 paragraph 3.c is in conflict with the Financial Procedures and Policies Manuals. This had been previously noted in the amendment review comments of this Committee.

C-12 Marine Activities Advisory Committee: The Association president Doug Parks has reported that this resolution will be referred to the committee for the review that has been requested by By-Laws and Resolutions Advisory Committee.

M-05 Animal Control and M-07 Bulkhead and Waterway Maintenance: The Association president Doug Parks has reported that these resolutions have been referred to the directors for review as requested by this Committee.

F-04 Delinquent Assessments: There has not been a response to the Committee comment that there is no evidence of a 2019 report as required by F-04.

F-02 Annual Budget Development: There has not been a response to a Committee inquiry regarding possible amendment to the budget approval date and questions regarding the current approach to board meeting reports.

M-02 Amenity Policy: There has not been a response to the Committee request for status of the M-02 proposed amendment that had been through a first reading.

Documents for Board Review: This link on the Association website had been previously reported to have documents that were no longer relevant for review purposes. The link has been removed from the website.

#### **NEW BUSINESS:**

Annual Committee Report per C-01: The Committee discussed the annual report. This report is as of September 30 and due to the Board October 31. Additional consideration will continue at future meetings.

Notice for Membership Meetings: For information purposes, the chair noted that a recent newspaper article reported that the Elections Committee intended to correct an oversight regarding not sending the annual meeting notice to members without regard to voting eligibility. The chair also noted that the Charter, as well as the By-Laws, contains notice provisions.

Board Initiative for Restrictions Enforcement: For information purposes, the chair noted that the Board is considering a proposal to amend Declarations of Restrictions to permit a system of fines as a part of the enforcement of DR violations.

Although not an agenda item, the Committee looked at potential future business and decided to consider the need for meetings as meeting dates approach.

#### **GOVERNANCE DOCUMENT REVIEW:**

The Committee went through the Governance Document Review and updated the status. There will be a continued review of resolutions status in an effort to maintain resolutions up to date. The updated Governance Document Review is attached.
