1. The meeting was called to order by Dave Allen at 9:55 a.m.

## **OLD BUSINESS**

- 3. MARINE DEBRIS CLEAN-UP PROGRAM. The Debris Plunder, originally scheduled for May 15<sup>th</sup>, was cancelled due to weather conditions. Sandi Smith, with Maryland Coastal Bays Program, will be in touch with us through Sue regarding a meeting to plan another date for the event. It is most likely that this event will be scheduled in the fall.
- 4. <u>CONDITIONS AT WHITE HORSE BOAT RAMP, PARKING LOT, AND WALKING PATH</u>. Last month, Sue brought to our attention the situation at White Horse. As a private resident, Sue sent a long letter to John Viola, with photos. John acknowledged her letter and informed her that he referred this to Public Works.
- 5. <u>DREDGING AND CANAL DEPTHS</u>. Mike communicated with Linda Martin and obtained copies of the DRs. He reviewed them for every waterfront section in the Pines and found only one obtuse reference in Section 19 (Harbor Village). Mike also communicated with Paul Mauser, a city engineer with the Town of Ocean City. His email communication and Mr. Mauser's response is attached to these minutes for your review.
- 6. <u>NEWS BLAST AND FEEDBACK.</u> The Committee discussed kayak racks and the boat launch at Pintail. John discussed the status of the projects being addressed by Public Works. Donna advised that the boaters' shower has not been repaired as of Thursday, June 16, 2022.

7. <u>BLESSING OF THE FLEET AND SAFETY INSPECTIONS.</u> Jerry indicated that these took place on June 4, 2022. See new business for discussion about ways for OP boaters to obtain free boat safety checks.
